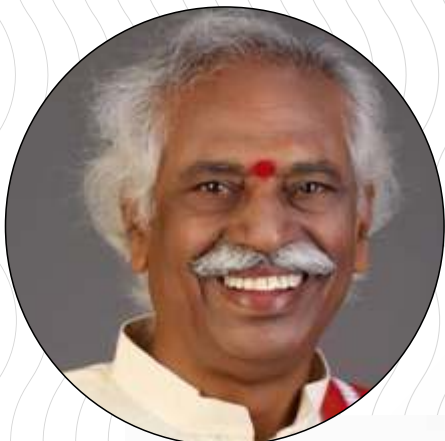

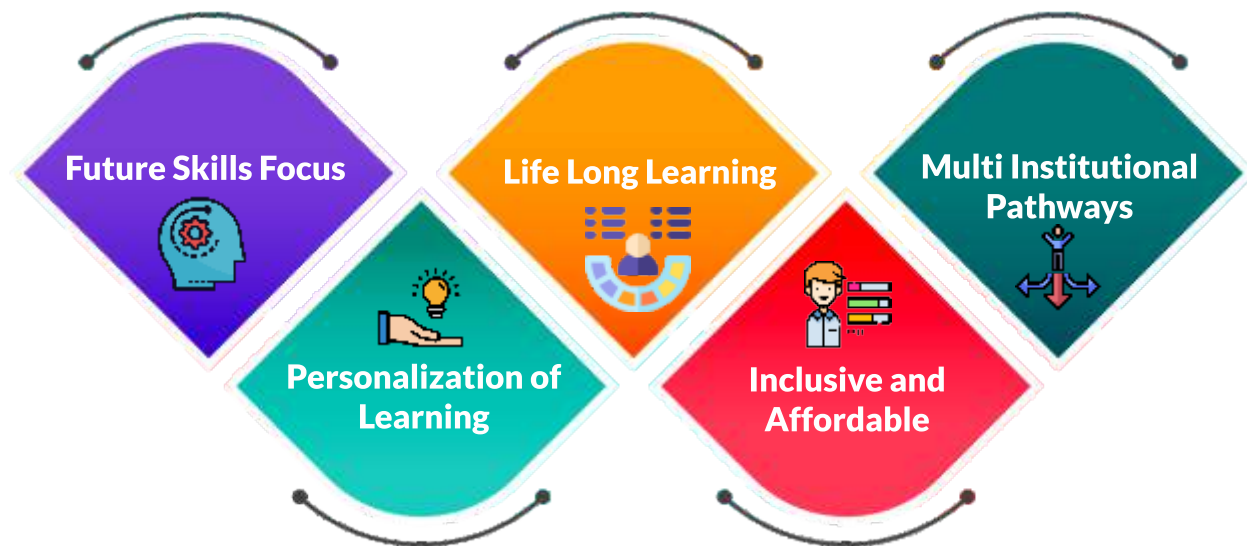

The motto “योग: कर्मसु कौशलम्” has been adopted from Shrimad Bhagwat Gita (Chapter 2. Verse 50). Any work becomes valuable if done with full concentration, dedication and skill. The blue colour of the logo denotes that the Shri Vishwakarma Skill University is committed to uphold the dignity of skill and labour. Seven dots represent saptarishis in the universe who are collectively bringing the unrevealed wisdom, philosophy, science and knowledge of cosmos to connect with human mind to skill them to think out of box, with infinite limits.

The centre piece collectively represents the spirit of ideation, creativity and progress encompassing the best of traditional and modern values and wisdom. The pen nib and spanner remind us to work with our own hands to acquire knowledge and skill, till perfection is achieved. Wi-Fi symbol and the monitor stand for the global connectivity and digital learning. The red arrow is indicative of sustained progress with adaptability to change. It also bridges the shift between our roots and the future via the means of technology.

Holistically, the logo resembles a thoughtful mind integrating knowledge, value, ethics and skills for innovative thinking. It resounds the philosophy of the university to create young minds full of new ideas and thoughts and having skills to transform them into reality for upliftment of mankind.

Lord Vishwakarma who is known to be the architect of this universe is also the designer of all flying chariots of Gods and their divine weapons. Chariots have significant place in our civilization. These were driven by horses and also known for the purpose, speed and dynamism. It is over such chariot, aeons ago Lord Krishna revealed the Principles of Karma to Arjuna that guided him to the path of purposeful action and also set the direction for generations to beacon with. We take inspiration from the chariot and connect with the legend of Haryana, that is Mahabharata. 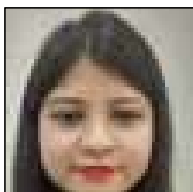

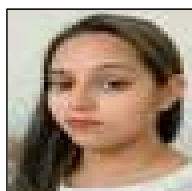

SVSU has built a strong partnership with the industry to facilitate student's employability and entrepreneurship through On-the-Job Training (OJT).

The University has designed, developed and deployed Industry Integrated Dual Education Model (IIDEM) that facilitates "Earn-While-Learn" and provides the students with the opportunity to enhance their qualification with flexibility of entry and exit into a programme. SVSU has conceptualized IIDEM programme with various Industry Partners, which is designed in such a manner where 60% of the credits are earned through Skill Enhancement Component courses, integrated with National Apprenticeship Promotion Scheme (NAPS), offering stipend.

The classroom training shall be imparted by the SVSU faculty and other industry experts. Practical & workshop experience are the key components of the overall training methodology. 40% of the credits shall come from the theoretical and conceptual training. The entire pedagogy is designed to develop application-based experiential learning that will make students job-ready from day one.

Every Skill Faculty also offers PhD Program. The seats and the admission process of the PhD programme will be announced separately.

On-the-Job Training (OJT)

The OJT is a mandatory constituent of the Programmes offered by SVSU. The department accommodates the students to get OJT across different job-roles in each semester so as to focus on outcome-based learning. As a part of programme's training delivery, all students have to undergo OJT scheduled at the industry partner's shop floor/ workplace to work on the actual machines/ business processes. OJT working hours are linked to the required credits for the programme. The daily duration of OJT shall be a maximum of nine (09) hours. The OJT shall be carried out under the supervision of supervisor-cum-trainer nominated by industry partner. The OJT areas are subject to availability; students cannot claim for specific OJT areas. It is mandatory that students comply with industry OJT requirements including rules and discipline prescribed by the OJT partner. The stipend during the OJT will be the discretion of industry partner and it may be offered with or without stipend. OJT location may vary as per industry partner requirements anywhere in India and students are required to follow the necessary guidelines.

After deployment of the students in the industry, students are registered on Digital OJT Diary Platform and login credentials are created and shared among the students. On daily basis students have to fill the learning outcomes of the day regularly and OJT mentor as well as Industry Mentor assesses the performance of the students on regular basis.

The students going on OJT are also assessed on the basis of reports of Digital OJT Diary Portal encompassing both internal and external marks.

The students during their OJT shall:

- Work in the available OJT areas as assigned by SVSU/ industry mentors.
- Observe the industry's occupational health and safety rules and processes.
- Follow the rules and instructions of SVSU and OJT partner.
- Abide by the rules and standard operating procedures of the industry as applicable to
- Work on the shop floor/ work place.
- Be in the uniform of University/OJT partner as applicable.
- Attend the OJT on a regular basis. Students must have a minimum of 90% attendance during OJT in order to be eligible for the end semester examination.

Every student is required to fill the following on daily basis on the online OJT diary -

1. One Observation of the day
2. Job Assigned
3. Machines/SOPs used
4. Skill learnt
5. Challenges faced
6. Ideation, if any

Admission Procedure

Overview

1. For Out-Campus programmes : In case of minimum age of 18 years mentioned in the list of programmes under various skill faculties, the student must have attained the age of 18 years as on 10-01-2024 for programmes in which OJT will be offered in 2nd Semester for Bachelor programmes and 18 years as on 15-08-2023 where OJT shall be started in 1st Semester (BVoc Mechatronics Hero Motocorp) For D.Voc. programmes, the minimum age of 16 years shall be on closing date of admissions as per the admission schedule notified by the University. For rest of the programmes, the minimum age mentioned against the programme shall be as on 15-08-2023. In case of deviation, the decision of CA shall be final.
2. For In-Campus programmes: there is no minimum age of applying for admissions.
3. No. of seats may increase or decrease without any personal communication to the candidates.
4. In such programmes where the industry partner has yet to be determined, detailed information will be released later.
5. The stipend will be paid at the discretion of the industry partners and will be paid exclusively during the OJT period. It is not a matter of right.
6. If the number of students admitted in a programme is less than 30% of sanctioned intake, programme will not be offered. However 100% fees will be refunded on the request of student or student may be allowed to select other programmes based on his or her eligibility subject to availability of seats, however student will have to comply with the selection procedure.
7. The programmes are offered in collaboration and consultation with Industry partners. If proposed industry partner does not accord consent, the programme may not be offered session 2023- 24. The Industry partners are tentative and may be subject to change.
8. This is for applicable cases for relaxation in minimum eligibility marks for reserved category (SC/ST) Candidates. The Chief Secretary to Govt. Haryana, Chandigarh conveyed the instructions vide letter No. 22/129/2013-1GS III dated 16.07.2014 regarding prescribing minimum eligibility qualification for the various courses for reserved candidates as per the procedure in compliance with the judgment of Hon ble Supreme Court passed in CWP No. 7084/2011 e.g.“A General candidate requires to have 50% marks, then as per Govt. instructions by giving 5% relaxation the minimum eligibility marks for a reserved caste candidate should be calculated as under:-
Out of 100 marks needs to less = 5
Out of 1 Marks needs to less = 5/100
Out of 50 marks needs to less = $(5/100) \times 50 = 2.50$
This way, minimum fewer marks where general category candidates are required to have 50% in a prescribed qualification, the total required marks for reserved candidates will be $50 - 2.50 = 47.50$ and not 45.”

Note (Supernumerary Seats):-

- 02 seats will be available in each programme with an intake up to 30 for the domicile/ residents of Dudhola village Panchayat (s), who have gifted their land free of cost/on-lease to the state government (As per notification of the State Government).
- 01 seat is reserved for migrants from J&K in each programme.
- 10% seats are offered to women candidate in each programme (Except B.Tech/M.Tech/MBA/MBA Executive/ Lateral Entry) Details mentioned in Annexure A-1.
- 01 seat for the industry sponsored women candidate in each programme (Except B.Tech/M.Tech/MBA/Executive MBA/ M.Phil (CP)/Lateral Entry). Details mentioned in Annexure A-2.

In the event of quota reserved for Physically Handicapped remains unutilized due to non-availability for suitable category of Handicapped Candidates, it may be offered to the Ex- Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%). Further, 3% reservation is also provided to Ex-servicemen/ Freedom Fighters and their dependents by providing reservation within reservation of 1% out of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block-B of Backward Classes category is concerned, year wise rotational system will be adopted. For example, if Block-A of Backward Classes are given seats in academic year 2023, the next Block i.e., (B) Block of Category of Backward Classes will be given seats in the next academic year 2024 and so on. Further, a roster register for reservation of seats for ex-servicemen/freedom fighters shall be maintained and carry forward all fractions, till one seat is accumulated through different fractions over the years. As and when the total comes to one, a seat will be provided.

Fifty percent of the twenty percent seats reserved for Scheduled Castes for admission in any educational institution shall be provided to candidates belonging to deprived Scheduled Castes as enumerated in the Annexure: B-1.

Where a seat is reserved for candidate from the deprived Scheduled Castes for admission in Government Educational Institution is not filled up in any academic year due to non-availability of candidate of the deprived Scheduled Castes possessing the requisite qualification, the same shall be made available to the candidate of Schedule Caste.

- The reservation of seats in various programmes is per the reservation policy of the Government of Haryana and is subject to change/amendments made by the Government from time to time.

Guidelines for Admission

1. The reservation of seats will be as per the latest Reservation Policy of the State Govt. revised from time to time.
2. All the eligible candidates irrespective of their category shall be considered first for AIC seats.
3. All eligible candidates deemed to be bonafide residents of Haryana for Admission purpose irrespective of their category shall be considered first for HOGC seats.
4. Candidates who have passed their qualifying examination from a University/ College/ School situated within the State of Haryana, will be deemed Haryana Residents and will not be required to submit certificate of Bonafide Resident of Haryana notwithstanding the intentions in Annexure B-3 VIII(2)
5. The admission process for all Programmes will be held in Physical mode only. No request for attending counselling in online mode shall be entertained.
6. The Provisional Merit List will be prepared category wise for all programmes. Accordingly, Seat Allocation list for all admissions will be displayed on the University website. No personal communication shall be carried out.
7. The candidate(s) will have to deposit fees through DD/online mode (Debit/ Credit card/ Net banking) as per the dates mentioned in the counseling schedule. Accordingly, the Provisional Admission Letter shall be issued after the fee deposited by the candidate if the candidate seeks.
8. If a candidate does not deposit the fee, then he/she will not be allowed to participate in the subsequent one counseling. However, he/she will be allowed to participate in the subsequent cycles of counselling (if any) and also will be allowed to participate in "On the Spot Admission" counseling (date to be announced later on) on the availability of seat(s).
9. If at any stage, it is found that the candidate has supplied incomplete and/or false and/or incorrect information, his/her candidature for the programme, if admitted, will be cancelled and he/she will be liable for disciplinary action as per the university rules and the fee deposited by him/her shall be forfeited.
10. The seats remaining vacant in different categories after each cycle of counseling will be offered to the respective categories in the subsequent counseling. The schedule of the counseling(s), if any, will be announced later on and shall be published on University website.
11. If any seat in BC (B) category remains vacant, the same will be filled up from BC (A) category and vice-versa after second counselling or after the candidate of a particular category is exhausted.

12. If any seat in SC category remains vacant, the same will be filled up from SC(D) and vice-versa after second counselling or after the candidates of a particular category is exhausted.
 13. The seats reserved for Economically Weaker Sections (EWS) candidates, if remaining vacant after the Physical counselling(s) will be first offered to the candidates of the EWS at the start of the physical counselling as per schedule notified, after being offered to the candidates of EWS if seats still remain unfilled after cutoff time as per schedule, the same will be converted into General Category of Haryana as the case may be.
 14. Benefit of reservation will be given to all the reserved categories upto 3rd Merit List. In case reserved seats other than SC seats are vacant even after 3rd Merit List, then these vacant seats will be thrown open to Haryana General Category. In case, the seats in Haryana General Category remain vacant at the end the same will be thrown to All India Open Category.
 15. Seats belonging to any reserved category will be converted to unreserved category as decided by the university in accordance with the rules of Government of Haryana. However, candidates belonging to respective reserved category fulfilling other eligibility conditions will also be considered on priority basis within the limits of time as decided by the University. In the event of seats remaining vacant/unfilled, if any, the same shall be filled up before final cut-off date of admissions without any reservation.
 16. Further, the Vice- Chancellor is authorized to add any instructions related to counselling for all the programmes.

Guidelines for Registration and Fees Submission

1. University issues the notice of registration and fee deposition in every semester as per academic calendar.
2. The students are required to deposit their Registration form with applicable fee as per the schedule without late fee.
3. After that, the students are allowed to submit their Registration form with applicable semester fee with a fine of Rs.10 per day as per the schedule notified by the University.
4. University notify the list of registered students who are allowed to attend the classes/OJT
5. Last opportunity is provided to students for re-admission for another 10 days subject to the fulfilment of conditions as per university norms. The Un-registered students may apply for Re-registration/Re-admission with recommendation of Program coordinator and respective Dean/Chairperson with semester fees, a Re-admission fee of Rs.1000/- and a fine of Rs.10 per day by taking into consideration of 75% attendance for Theory and 90% for OJT in the semester from the date of re-admission which is mandatory condition for all the students.
6. The students may attend the classes/OJT from the date of registration/Re-admission.
7. Students who failed to submit the fees as above, their names will be struck off from the University records and will not be allowed to attend the classes.

General Instructions For Online Application Form

1. Before filling the Online Application Form, candidates are required to read the Prospectus/ Guidelines/Instructions available on University website carefully. Candidates will submit their Application Forms online on the University's website: www.svsu.ac.in for admission to various programmes.
2. No column should be left blank in the Online Application Form; write N.A. against the column which is not applicable. Otherwise, it will be considered as incomplete and is liable to be rejected.
3. In case any candidate is found to have supplied false information, certificates, documents, etc. or withheld or concealed some information in his/her Application Form, he/she shall be liable to be debarred from admission to the programme.
4. If a candidate is admitted on the basis of the information submitted by him/ her, which is found to be incorrect or false at a later stage, his/her admission will be cancelled and all fees and other dues paid by him/her shall be forfeited. The University/Faculty may also take further action, as deemed fit, against the candidate and his/her guardian.
5. Any legal dispute relating to admission of students will be subject to Courts at Palwal/Gurugram or Courts having jurisdiction in Palwal/Gurugram.
6. Every student must be in possession of AADHAR number at the time of admission.

For the removal of any discrepancy as noted by the admission committee required for the purpose of admission may be given sufficient time with information displayed on the University's website. Days and Dates would be displayed in the Admission Schedule.

General Instructions for counselling

1. The merit list based on the selection criterion and reservation policy of Government of Haryana shall be published on the University website.
2. The admission-counselling schedule will be published on University website. University will not make any personal communication.
3. All the applicants mandatorily attend the admission counselling as per the notified date and time and location. No request of online attending of the admission counselling shall be entertained.
4. Requisite fees as per the programme will be accepted through Debit card/Credit card/Bank Draft and will not be accepted in cash.
5. Candidates are required to bring all their original certificates along with two sets of self-attested photocopies on the day of the counselling. Departmental Admission Team will check the eligibility of the candidates. In case the candidate is found ineligible as per the published criterion, his/her candidature will be cancelled.

9. Candidates seeking admission for Haryana seats are required to submit a certificate of bonafide resident of Haryana as defined by the Haryana Govt if they have not passed their Qualifying exam from a Board/ University of Haryana. The Certificate of Haryana Resident shall be in the formats prescribed by the Govt. and issued by the competent authority.
10. A complete merit list of all eligible candidates will be prepared for each category.
11. Candidates having passed qualifying examination from self- styled Universities/Institutes/Boards declared bogus/fake by UGC and other govt. bodies shall not be eligible for admission to any programme in Shri Vishwakarma Skill University. This list may vary from time to time as per Notification of UGC/ other govt. bodies.
12. Any attempt on the part of a candidate, his/her friends, or relatives to canvass or bring influence to bear upon the University directly or indirectly for securing admission will lead to disqualification for admission.
13. If a candidate is admitted on the basis of information submitted by him/her but at any subsequent time, it is discovered that any portion of this information is incorrect or false, the student shall be rusticated from the University and all fees and other dues paid until the date of such removal shall be forfeited. Rules of Refund of Fees after Cancellation of Admission

Rules of Refund of Fees after Cancellation of Admission

The University strictly follows UGC/AICTE guidelines for refund of fees published time to time.

In case of the cancellation of admission. The following clause of UGC, vide Notification dated October, 2018, for 'Remittance and Refund of Fees' will be followed: -

4.1.3. If a student chooses to withdraw from the program of study in which he/she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees** remitted by the student.

Sr. No.	Percentage of Refund of fees**	Point of time when notice of withdrawal of admission is received in Higher Educational Institutions (HEI)
1	100%	15 days or more before the formally-notified last date of admission
2	90%	Less than 15 days before the formally-notified last date of admission

4	50%	30 days or less, but more than 15 days, after formally-notified last date of Admission
5	00%	More than 30 days after formally-notified last date of admission

**NOTE:

4.1.4 In case of (i) in the table above, the Higher Educational Institution (HEI) concerned shall deduct an amount not more than 5% of the fees paid by the student/s, subject to a maximum of Rs. 5000/- as processing charges from the refundable amount.

For B.Tech programmes, guidelines of refund of fees shall be followed as issued by HSTES/AICTE.

At Last, I would also like to share one success Mantra which I got from elders i.e. We should always listen to others because you get something and does-not lose anything. Whatever knowledge you have will not vanish but being a good listener, you will gain some extra knowledge which will definitely be helpful in your future life in one way or the other.

Students are expected to abide by University's rules and regulations and maintain discipline. As adults, they should conduct themselves in a manner that is in consonance with civilised behaviour and courtesy. Defaulters will be subject to disciplinary warning/action/expulsion from the University for a Term Basis or forever, depending upon the severity of the case. For major punishment, such as expulsion/rustication from the University, making an adverse entry on the Character Certificate to be issued by the University and debarring a student from admission to any programme offered by the University etc. the decision will be taken by the Dean or as per the recommendations of Students' Discipline Committee of the University. Students must possess their Identity Cards all the time and produce the same whenever asked. University's ordinance 'Enforcement of Students' Discipline, Good Behaviour, Residence & Health' should be followed for such cases of indiscipline.

Without prejudice to the general meaning of indiscipline, the 'acts of indiscipline' inter alia include the following:

- A. Misconduct or misbehaviour in the classroom/OJT/Industry/center of excellence or anywhere on the University campus or outside the campus on visits authorized/deputed by the University or during tours/trips/surveys/internship (in company training) forming part of the curriculum;
 - B. Causing damage or defacement to University/Industry property.
 - C. Instigating or causing to instigate, organizing/participating in strikes, demonstrations, or disturbances of any kind, including gherao or lock-outs which may disrupt the convocation, admissions, examinations, workshops, conferences, and other functions of the University/working of industry partner.
 - D. Disobedience or disregard of instructions or notifications issued by Chairpersons/In charges members of faculty, and other officers of the University/Industry partner.
 - E. Instigating or causing to instigate, misguiding the employees/workers of the University to indulge in activities contrary to the interest and discipline of the University/Industry partner.
 - F. Persuading students to be absent from classes/OJT/examinations, disrupting the conduct of classes/OJT in any manner and other academic activities of the University/Industry.
 - G. To act or cause/instigate others to act in such a manner as to create disturbance or annoyance to other students/inmates of hostels/employees of University/Industry partner/residents of the campus community/any other person on the University campus/Industry or otherwise/or to act or cause/instigate others to take law into their own hands.
 - H. Keeping, carrying, using, or supplying of any arms, lethal weapons, knives with a blade of more than four inches length in the hostel from or outside or within the University/Industry.
 - I. Keeping, using, or supplying intoxicants/drugs in any form in the hostels, within the University campus/Industry partner premises.
 - J. Gambling/betting in any form on the campus/industry.
 - K. Ragging, bullying or harassing of students in the classes/OJT/hostels within/outside the campus/industry.
1. Ragging for the purpose of this Ordinance, ordinarily means any act, conduct, or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which:

- A. Involve physical assault or threat to use physical force.
 - B. Violate the status, dignity, and honour of women students and students belonging to scheduled castes and tribes.
 - C. Expose students to ridicule and contempt and affect their self-esteem
 - D. Entail verbal abuse and aggression, indecent gestures, and obscene behaviour.
 - E. Recourse to violence, assault, intimidation, or rioting within or outside the campus/industry.
 - F. Disturbing other students in their studies.
 - G. Attending or organizing unauthorized meetings and participating in such meetings.
 - H. Displaying notices, leaflets, or posters, not signed or countersigned by competent authority at the hostel notice board and of the University notice boards or other places or distributing such notices or leaflets or defacing University buildings/Industry or writing slogans and undesirable things on the buildings/property/Industry premises walls, etc.
 - I. Forging of signatures in any way of the faculty members/students at the time of registration/any other time, submitting fake certificates.
 - J. Eve-teasing, molestation, and physical assault, or threat to use physical force against any member of the teaching and non-teaching staff of any Institution/Department (Branch Officer/ library) and against any student within the University/Industry.
 - K. To give shelter to outsiders/students in the hostel when the stay/visit of such student/outsider has been expressly barred by the orders passed by the University for a specific period or for a general period.
 - L. To indulge in an act which may bring disrepute to the University/Industry in any manner.
 - M. Any practice- whether verbal or otherwise-derogatory to women.
 - N. Creating ill-will or intolerance on religious, caste, or communal grounds.
Any other act which, in the opinion of the Vice-Chancellor or any other officer authorized by the Vice-Chancellor in this regard, is considered to be an act of indiscipline.
2. In the light of the orders of the Hon'ble Supreme Court of India on 'Curbing Ragging in Educational Institutions', ragging in any form is totally banned by the University. If any ragging comes to the notice of the authority, the concerned student shall be subject to strict disciplinary action as per procedure. In this regard, students and their guardians are required to sign an affidavit that the students will not be involved in ragging in any form directly or indirectly.

The 'National Ragging Prevention Program' has simplified the procedure of filing an affidavit by each student admitted to SVSU. The affidavit can be filled on-line and shall neither involve the visit of the students to any court of law or advocate nor incur any expense.

The following procedure has to be followed:

1. Log on to www.antiragging.in or www.amanmovement.org
2. Click on 'Anti ragging Affidavit'/'Online Affidavit'.
3. Read the instructions carefully and proceed by clicking on 'Next'.
4. Fill in the information as asked for in the form(s).
5. On successful completion, you will receive the affidavit (both for the student and the parents) by e-mail.
6. Print out the form(s) and sign them.
7. Submit the signed print-out to the Dean/Head of the concerned department.

IMPORTANT NOTE: It is mandatory to complete this process immediately after admission within a maximum time limit of 30 days as per the order of the Honourable Supreme Court and Govt. of India Notification. (Sample is as per annexures B14 A and B14B).

Attendance And Leave Rules

- A. Student shall be required to attend a minimum of 75 % in each subject of the delivered lectures (in theory and practicals combined) and 90% of On-the-Job-Training (OJT).
- B. Attendance will be counted from the date of start of session to the date prior to the end of the semester.
- C. In case of late admission in the first semester, attendance shall be counted from the date of actual admission of the candidate by the competent authority.
- D. Every student shall attend his/her classes/On-Job-Training (OJT) on all working days unless he/she is granted leave of absence by the Chairperson of the University Teaching Department/Principal of College/Institution concerned. If a student remains absent from his/her classes/OJT for a continuous period of fifteen/seven working days respectively without any valid reason, medical or otherwise, his/her name shall be struck off from the rolls, irrespective of the fact that student has paid his/her dues.
- E. Any indiscipline reported by the Industry partner during OJT will lead to disciplinary action and/ or withdrawal from OJT
- F. Such student, whose name is struck off from the rolls of the Department/College, shall pay the re-admission fees of Rs. 500/- for making necessary entries in the University Register, subject to the recommendation of the chairperson of concerned department and principal of the college/institution that if re-admitted, the student will not fall short of the requisite percentage of lectures. No further request for re-admission will be considered in any case.
- G. A student, whose name has been struck off from the roll of the Institution, may, however, be readmitted if the absence of the student was due to the circumstance beyond his/her control and his /her request was considered and approved by the Dean / competent authority.
- H. Any student who fails to appear for or pass any particular exam and further thereafter remains absent from the University for a period exceeding one year from the date of re- opening of the institute following the exam in which the student had failed to appear or pass shall not be entitled to continue his/her studies in the institute without prior written permission of the competent authority.
- I. The Program Coordinator/Head/Industry Partner may grant leave to the students in exceptional circumstances only to the extent of 10 days per semester subject to the condition that the student completes the prescribed minimum attendance as per attendance rules and leave was sanctioned before availing the same.

Schemes and Scholarship

ABHINANDAN: Veer Balidani Kritagyata Yojna (AVBKY)

This is a special scheme for the wards and spouses of martyrs and gallantry award winners from the Indian security forces.

1. India is constantly at war with the forces inimical to its sovereignty, freedom and unity. Our security forces - Armed Forces, Central Armed Police Forces and State Police have been fighting such disruptive elements resolutely, at times, offering their supreme sacrifice at the altar of the nation.
2. Every year hundreds of security forces' members lay down their life in line of duty. For the families of martyrs, it is a major trauma in their lives – emotional as well as financial.
3. While respective security forces' organisations have their own system of looking after the affected families, there is a requirement of providing a platform to the spouses and wards of the martyrs and gallantry award winners to help them pursue skill-based formal education.
4. It is with this thought in mind, Shri Vishwakarma Skill University has launched Abhinandan: Veer Balidani Kritagyata Yojna, proposing to provide opportunities of skill-based education to the spouses and wards of the martyrs and gallantry award winners of the members of the security forces.
5. The eligibility for Abhinandan: Veer Balidani Kritagyata Yojna (AVBKY) is wide-based covering the members of Armed Forces, Central Armed Police Forces and State Police who have laid down their life for the motherland or won a gallantry award in multiple terrains and variety of conflict situations.
6. Shri Vishwakarma Skill University is offering ten (10) AVBKY scholarships for its academic session 2023-24. The scholarship shall be covering the tuition fee, hostel fee, messing, uniform and once in a year to and fro rail fare for the student.

“Har-Chhatravratti” is a centralized portal developed by the Department of Higher Education that provides one stop solution for end-to-end scholarship process right from submission of application, verification and disbursal to end beneficiary. Keeping in view the State Government's commitment to make beneficiary-oriented schemes easily accessible, seamless and transparent, a centralized State Scholarship Portal has been developed by bringing in 13 scholarship schemes of 5 major department of the government under a single platform.

Student Application form got verified from three levels i.e. Institute, University/Nodal Body and Head Office thus ensuring the complete authentication of the applicant. This portal is also integrated with state flagship programme i.e. Parivar Pehchan Patra (PPP) scheme of Haryana Government. In order to avail the benefits of scholarship schemes of the state government, it is mandatory for each applicant to have Parivar Pehchan Patra (PPP). Har-chhatravratti portal would also include the students of Haryana domicile who are studying outside Haryana. Such application would directly be verified by the concerned department.

National Scholarships Portal is one-stop solution through which various services starting from student application, application receipt, processing, sanction and disbursal of various scholarships to Students are enabled.

Objective of NSP

- Ensure timely disbursement of Scholarships to students
- Provide a common portal for various Scholarships schemes of Central and State Governments
- Create a transparent database of scholars
- Avoid duplication in processing
- Harmonisation of different Scholarships schemes & norms

1. INTRODUCTION

Skill Education has played a very significant role in employment generation and nation building all over the world. It is visible that no culture and nation can rise without strengthening the skill education system in the nation. It requires motivation for students to take skill-based education. There is a need to attract young and talented students to pursue Skill education. It is observed and on the basis of skill gap analysis that the brighter lot is not pursuing Skill Education in our universities. To emerge as a powerful state and nation, there is a need of motivating and attracting talented boys and girls to take admissions in the Skill education by way of providing them scholarships. The University, therefore, introduced an Industry Scholarship Scheme for the students.

The scholarship may be tenable for a period of one/two/three/four years to enable the students of the university at D.Voc./Diploma/Undergraduate/Post graduate level. The purpose of this scheme is to attract talent for pursuing diploma, under graduate and post graduate studies.

2. OBJECTIVES OF THE SCHEME

The objectives of the scheme are:

- a) To promote quality of skill in learning and education with regards to engineering, management, agriculture, humanities and vocational education at under graduate levels
- b) To Encourage students to demonstrate a consistent desire to improve and excel in their chosen fields of learning and development that leads to their higher employability, innovation and ideation.

3. NUMBER OF SCHOLARSHIP AND TENURE OF SCHOLARSHIP

APJ Abdul Kalam scholarship scheme Sponsored by the Oswal Endowment is For Diploma /D.VOC/UG/PG *students of SVSU. Every year the scholarship will be carried forward and also will be granted to 1st year students.

*Minimum one scholarship will be granted to the B.Tech Student.

4. ELIGIBILITY

1. To grant Scholarships to needy and meritorious first year students, who passed class XII/UG examination and have secured minimum 60% marks and whose family income is less than Rs. 3,00,000/- per year and as such are in need of financial help to pursue further studies. Marks and Income criteria may be relaxed in the specific cases at the discretion of the Competent Authority.
2. For Subsequent year, the scholarship will be provided on the basis of the progress report based on their attendance, discipline, class participation, overall behaviour and recommended by Chairperson.

5. HOW TO APPLY

The scheme once approved shall be published on university intranet for the information of all the students. All eligible students can apply in a prescribed format.

6. MONITORING / OPERATION OF THE SCHEME

The scholarship will be disbursed through SVSU Skill Innovation foundation of the university.

7. FINANCIAL ASSISTANCE UNDER THE SCHEME

The financial assistance of Rs. 2,00,000 per year in addition to the amount of scholarship sanctioned to the students in the previous years will be sponsored by The Oswal Endowment to the needy and meritorious students of the university who wants to pursue D.Voc/Diploma/Graduation/Post Graduation*in SFET. Total amount of scholarship to the student will be the percentage of total annual fees (including all funds) of the programme that will be decided by the committee. The scholarship of the students will continue till the completion their course provided the student satisfy the eligibility for the subsequent years.

*Minimum one scholarship will be granted to the B.Tech Student.

The awardee, under the scheme, will be provided the scholarship of total semester fees per semester for a period of one/two/three/four years. The second year grant will be released after reviewing the performance on the basis of progress report based on their attendance, discipline, class participation, overall behaviour of the first year and recommendation of Chairperson.

*Minimum one scholarship will be granted to the B.Tech Student.

No other additional grants will be payable in lieu of hostel charges and medical charges etc.

8. OTHER CONDITIONS

- The student who is awarded this Scholarship will be debarred from accepting any other scholarship from any external agency related to fees.
- Students desirous of leaving the studies mid-way without completing the degree will have to take prior approval from the department by submitting an application with justification through the chairperson.
- The Department has to submit the information of completion of the D.Voc./Diploma/ Undergraduate programme/ Post Graduate in respect of each student availing this scholarship to SVSU skill foundation.
- No extension is permissible beyond the complete duration of the programme.

9. CANCELLATION OF SCHOLARSHIP

The University may terminate the scholarship of any student in case of:

- Misconduct of the awardee, if any, reported by the Department.
- Unsatisfactory progress report)
- Candidates being found ineligible at a later date shall face the penal action and will also be liable to refund the entire Scholarship amount paid to SVSU Skill Foundation, SVSU.

10. DOCUMENTS TO BE SUBMITTED

- Attested copy of proof of age
- Self-Attested proof of parents income (certificate from a government body e.g. income certificates/salary slip) or Form 16
- Self-Attested 10th Standard mark sheet
- Self-Attested 12th Standard mark sheet
- Self-Attested Under Graduate mark sheet.
- JEE Rank sheet in case of B. Tech students
- An essay (not more than 600 words) about yourself and why you have decided to pursue the chosen course of study and how the scholarship will help you, which is to be handwritten by yourself. For subsequent years, self-attested last passed semester mark sheet.

11. CERTIFICATE TO BE SUBMITTED BY THE CONCERNED DEPARTMENT TO SVSU SKILL FOUNDATION

Every year Department/s, will submit a compiled statement for the following:

- Statement giving the names of the students selected for the scholarship along with the scholarship amount.
- Progress Report to be submitted after the semester of the award giving percentage of marks obtained by the candidates.

12. SELECTION OF THE CANDIDATES

- The committee constituted/approved by the competent authority will determine the criteria and weightage and recommend the names of the awardee after receiving the application from the concerned departments. The committee may recommend more than one student from each programme/Skill faculty as per the proposed merit and need based.

A) Introduction:

Training and improvement are ongoing a methodical processes. Every teacher/trainer needs to emerge from the training process with a strong sense of professionalism, excellence, motivation, and satisfied students. A teacher/ trainer is a person who teaches or train students how to do their jobs. Consequently, the industry training is crucial to the accomplishment of the organization's primary and long-term objectives. The University has taken a transformational step in this area to support and upgrade the skills of the University's teaching staff by providing them an opportunity to be mentored by industry and understand the industry processes and requirement in order to enhance the learning in the classrooms. Industry Mentoring has shown to be one of the most valuable and effective development opportunities an industry can offer to teaching staff of an academic institution.

Having the guidance, encouragement, and support of experienced industry professional will lead to improved performance of a teacher/trainer and the students in the academic institutions.

B) Scope:

- To mentor teaching staff to understand the processes, requirements and technology used in the industry for making the students employable and job ready.
- To enhance the quality of teaching-training with in-service teaching staff development training for their roles as teachers or trainers.
- To make the teaching staff understand about new technologies and skills.
- To develop projects or create project-based learning environment in the university.
- To motivate teaching staff for industrial research by developing industryoriented research culture in university.
- To bridge a gap between industry and academia.

C) Who can be the Mentor?

Departmental head in the industry/ working industry professionals with 10 years' experience in industry can be the industry mentor of the teaching staff during the industrial training. The mentor can be nominated by HOD/CEO/MD of industry or self-nominated. The Mentees can also propose the industries and industry mentors for their mentorship as per the eligibility mentioned above.

D) Who can be the mentee?

Faculty Members/Master Skill Instructors/Senior Skill Instructors/Skill Instructors can be the mentees.

E) Training Duration:

Total duration of the training will be two weeks. It can be flexible and covered parts at multiple times in a year as per the availability and suitability of mentors and mentees not less than two days at a time.

F) Responsibility:

a) Responsibility of Mentor:

- Mentor should facilitate the learning of mentees in industry.
- Mentor should assign the area/ process keeping in view the recent trends, innovation and industry requirement.
- Mentor will provide or connect to provide insights on various relevant topics, issues related to industry and work that will help the academic mentee to improve his/ her understanding leading to academic innovations. The academic innovations can be in Curriculum Development, Teaching Pedagogy, Assessments, On the Job Training design for Students and Project Conceptualisation.
- The mentor may also expose mentee to the best practices adopted by the Industry.

Mentor should associate mentees in diagnosing the research problem in the running plant.

b) Responsibility of Mentee:

- Mentee needs to take required approval from the Competent Authority through Chairperson/Dean for joining the training.
- Mentee needs to follow the Industry/Organization rule, regulation and discipline.
- Mentee should not be involved in the industry dispute and other matters.
- Mentee must have 100% of the industry attendance during the training and submit the signed copy of attendance by industry mentor to the department.
- Mentee need to submit the Industry training report in proper format (attached). In addition to report, the mentee is to submit outcomes mentioned in Para (H) in the document.
- Mentee will have a prior conversation and concurrence from the chosen mentor for deciding the way forward for the mentorship.
- Mentee will take prior appointments from mentor for any meeting with them.
- Mentee will prepare an action plan as per the guidance of the Mentor.

G) Benefits to Mentor:

- Mentee will support to industry by conducting research and providing solutions to industry problems.
- Development of personal leadership and coaching style of Industry Mentor.
- Exposure to fresh perspective and new ideas emerging from academia-students interactions.
- Industry academia engagement.
- Service to community and society.
- Recognition as an industry mentor of teaching staff of India's first government skill university.
- Opportunity to get associated and contribute in organisation building and development.
- Opportunity to receive Best Performance Mentor Award.

H) Outcomes:

After completing the training, teaching staff will develop the following resources to enhance the teaching learning process which will be beneficial for the students as well as mentee members. The developed content will be the right of the university.

- Case study that is based on the industry problem and providing strategic solutions.
- Projects that is based on learning from industrial training
- Strengthen the industry academia relationship.
- Exploring the possibilities of collaboration with the industry in terms of designing RPL Programmes, MDP, EDP, short terms Programmes for the employees of the industries if required.
- Innovative Pedagogy

I) Recognition:

- Industry mentor will be recognized and provided a certificate of recognition and best performance mentor award on the foundation day of the university.
- Visibility in SVSU newsletters, website, annual reports and presentations at various platforms.
- Recognition as a subject matter expert.
Invitation as industry experts for industry talks, conferences, seminars, board of studies meetings and other committees.

Instructions regarding Bonafide Residents of Haryana issued vide letter No. 62/17/95-6 GSI

Dated 3rd October, 1996, No. 62/32/2000-6GSI dated 23rd May, 2003 and No. 62/27/2003- 6GSI

dated 29th July, 2003 by the Chief Secretary to Government Haryana.

Subject: Bonafide residents of Haryana-Guidelines regarding

I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of domicile for the purpose of admission to educational institution (including technical/medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble supreme court of India in the case of Dr. Pradeep Jain vs Union of India and other reported as AIR 1984-SC-1421, wherein it has been held that instead of the word Domicile the word Resident be used in the instruction issued by the State Government and it has been decided to revise the Government instructions.

Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate:

- I. Candidates, who have passed the examination qualifying there for selection in an institution from a school/college in Haryana.
- II. Children/Wards (if parents are not living)/Dependents of the:
 - A. Employees of Haryana State posted in or outside Haryana State or working on deputation.
 - B. Employees of the statutory bodies/corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana.
 - C. Employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government.
- III. Children/wards (if parents not living)/dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
- IV. Children/wards (if parents are not living)/dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a state other than Haryana or he has settled after retirement in or outside Haryana;
- V. Children/wards (if parents are not living)/dependents of persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana;
- VI. The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other state before marriage;
- VII. Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/guardians (if parents are not living) of persons belonging to any one of the above-mentioned categories are:
 - A. Citizen of India;
 - B. Produce an affidavit to the effect that they or their children/wards (if parents are not living)/dependents have not obtained the benefit of Resident in any other State.

VIII. Children & Wards of the accredited journalists residing at Chandigarh and recognized by Govt. of Haryana.

1. All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub-Divisional Officer (Civil) of the District/Sub-Divisions to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/Wards/Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi, or elsewhere or in respect of Children/Wards/Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/Dependents of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/Wards/Dependents of the employees and retirees of the Statutory Bodies/Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana, or outside Haryana, should be by their respective Heads of Departments.
2. Candidates, seeking admission in educational institutions (including medical and technical institutions) located in Haryana, may not be required to produce Resident Certificate if they have passed the examinations from a school/college situated in Haryana. For this purpose, a certificate of the Principal/Headmaster from the concerned institution, where the children/wards studied last should be considered sufficient. The Principal/Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
3. If a candidate is admitted on the basis of claim that she/he belongs to the State of Haryana but at any subsequent time is discovered that her/his claim was false, the student shall be removed from the institution and all fees and other dues paid up to the date of such removal shall be confiscated. 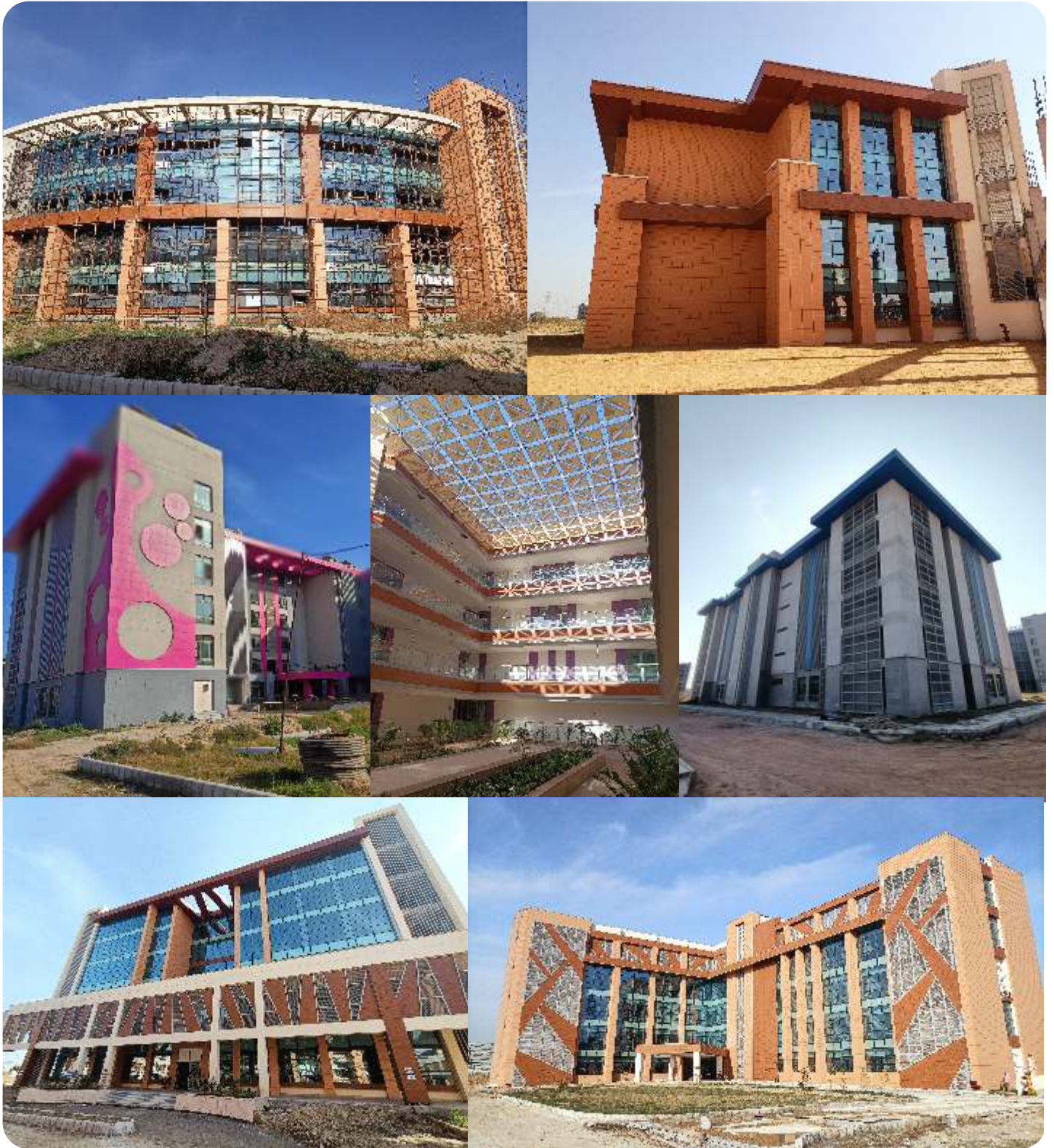

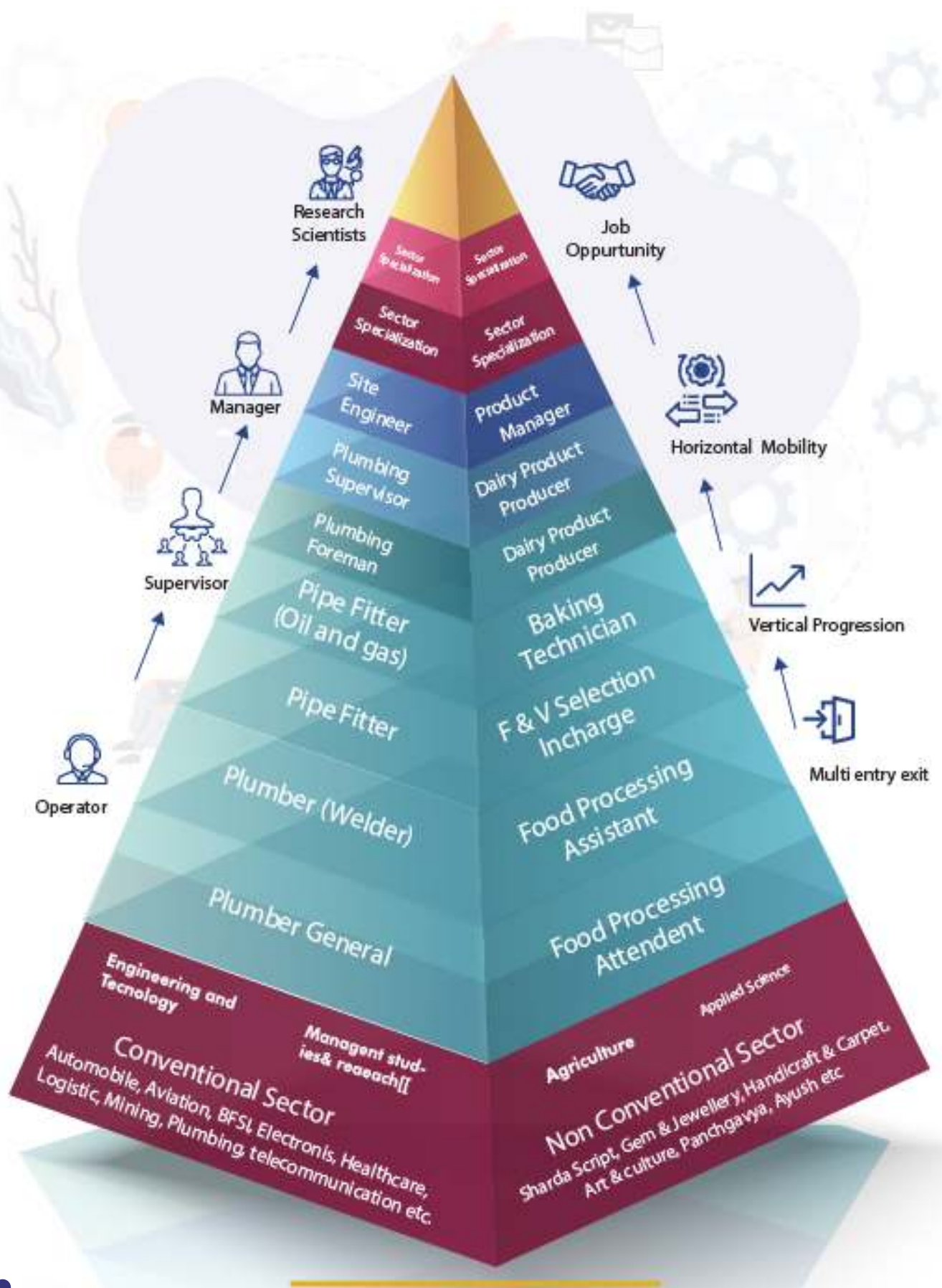
